Hi All,

All of you are in receipt of a recent email from Jim Shirk. Normally we have enforcement of the covenant covering architectural issues handled by the ACC (Architectural Control Committee) however since our Chairman, Jim Shirk has had an objection on the committee we need the Board and the ACC to provide a vote on this issue.

The following is an extraction from Jim's email: **Should the lack of an ACC request by Lot #2 to approve rock work on retaining walls be documented in the files and on the website? Yes or No.**

**Note: By documenting a covenant violation in the files, if the property is ever sold, the existence of the violation is communicated to the prospective buyer just as lien information is.**

Included with this email is the 2008 APPROVED request that clearly states the original intent was to do the facing on the dwelling and does not include the extended wall structure in front of the house and subsequent wall construction on the south side.

I need a YES vote that we should document this additional work as requiring separate construction requests and a NO vote that we should let it go without documentation.
